Having regard to:

1. The Provisions of Law 1316/1983 (Gov. Gazette 3 A/11-1-1983), as applicable and in particular indent f of par.1 of article 3 which was entered by par.1 of art. 17 of Law 4052/2012 (Gov. Gazette 41 A/1-3-2012).
2. The provisions of the Legislative Decree 96/1973 (Gov. Gazette A 172) and in particular of article 19 as applicable.
3. The provisions of the Joint Ministerial Decree no DYT3α/ G.P.32221/2013 (Gov. 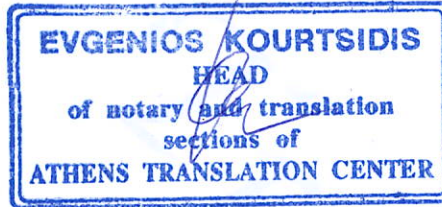
